Addendum

By a communication dated 17 July 1970 the Permanent Mission of the Republic of Gabon has informed the secretariat that, under Act No: 1/70 - UDEAC, dated 27 January 1970, the member States of the Central African Customs and Economic Union have adopted the following measures:

Article 1 - The customs duties established by Act No. 7/65-UDEAC-36 and set forth in the Customs Tariff of the UDEAC are hereby reduced as follows:

- by 75 per cent, the duties on pharmaceutical products falling within Chapter 30;
 - by 50 per cent, the duties on other products with the exception of those listed below, to which the rates of duty set forth in the Tariff shall continue to apply:
