Notifications received from contracting parties too late for inclusion in L/3377 (up to 3 April) are shown on the following pages. Apart from Benelux where a new list replaces two former lists, most of the material submitted is additional to what was already shown in L/3377 but some, indicated by an asterisk, comprise modifications of existing entries in L/3377.

BTN descriptions are not given to make the document more concise, but wherever restriction applies to less than the full 4-digit classification the scope of restriction is indicated in a footnote.

When notifications conflicted with each other, the broader coverage of restriction has generally been used.

(BQ--JAP) indicates a case where Japan is operating a voluntary export restraint on the understanding that this is the condition on which an import restriction has been suspended. Where BQ is shown without parentheses, followed by, e.g.: (JAP), (POL) or (YUG), discriminatory import restriction is operated by the importing country.

Besides the notifications in the table, attention has been drawn to the following:

1. Japan has an automatic import quota system affecting some 200 items which are listed in an annex to this document.
2. Austria, Ireland and Portugal, which invoke Article XXXV against Japan, maintain discriminatory restrictions against Japanese goods, on respectively 114, 47 and 267 items (not listed).
