

Schedule XXII - Denmark

The permanent mission of Denmark has transmitted to the secretariat the attached list of rectifications and modifications to Schedule XXII - Denmark annexed to the Ninth Protocol of Rectifications and Modifications.

The permanent mission of Denmark explains that the deletion of the tariff items enumerated in the list, with the exception of items ex 61.06 and ex 61.09, is a consequence of a revision of the Danish Customs Act, and that their withdrawal was notified in document SECRET/149, dated 11 January 1962.

With regard to items ex 61.06 and ex 61.09, the mission explains that they were included in Schedule XXII - Denmark annexed to the Ninth Protocol of Rectifications and Modifications due to a technical error in connexion with the conversion of the Danish tariff nomenclature to the Brussels Tariff Nomenclature.

If no objections are notified to the secretariat within sixty days from the date of this document, the rectifications and modifications submitted by Denmark will be considered to have been approved and will be incorporated in the Second Certification of Changes to Schedules.
