RESTRICTIONS ON IMPORTS FROM POLAND

Notifications to Contracting Parties

Addendum

The following notification on restrictions on imports from Poland has been received from the Government of Denmark.

A major change in Denmark's import control system vis-à-vis i.a. Poland took place on 1 January 1970 resulting in a high degree of liberalization.

On 30 June 1967 all imports into Denmark from Poland were subject to licences, while imports from market economy countries in most cases were free. (For details see document L/2740/Add.3 of 30 March 1967.)

The commodities which on 1 January 1970 were subject to discriminatory import restrictions when imported from Poland are listed in the annex to this letter.
