## GENERALIZED SYSTEM OF PREFERENCES

### Notification by Sweden

#### Addendum

With reference to the Decision of the CONTRACTING PARTIES of 25 June 1971 concerning the generalized system of preferences, the delegation of Sweden has transmitted the following information on the extension of the country's GSP scheme to Bulgaria, Malta and Romania.

---

On 5 December 1974, a bill was passed in Parliament, whereby the Swedish Government was authorized to extend the Swedish System of Preferences to the People's Republic of Bulgaria, the Socialist Republic of Romania and the Republic of Malta. The decision took effect as from 1 January 1975.

In the case of Bulgaria and Romania, preferential treatment will apply to the products listed in Annex I falling within BTN Chapters 1 to 24 and to products falling within BTN Chapters 25 to 99 with the exception of those listed in Annex II. As for Malta, preferential treatment will apply to the products listed in the Swedish notification of its scheme of preferences (cf. L/3666 and Add.3 and 4).
