GENERALIZED SYSTEM OF PREFERENCES

Notification by Austria

Addendum

The delegation of Austria has notified that the rules of origin of the Austrian scheme of generalized preferences have been amended as indicated below with effect from 1 July 1975.¹

List A (L/3697, pages 33-81)

1. The scope of application of the following entries in List A has been extended to cover the totality of the respective BTN heading Nos. (without prejudice to the product coverage of the Scheme): 03.02, 11.04, 15.06, 16.02, 16.04, 20.01, 20.02, 20.06, 20.07, 21.05.
2. The following BTN headings in List A have been deleted: 15.09, 21.02, 21.03, ex 28.19, 28.27, 29.02, ex 32.13, 34.02, ex 38.14, 48.07, 96.01, ex 98.15.
3. The following have been added to List A:

Products obtained		Working or processing that does not confer the status of "originating" products
BTN heading No.	Description	
07.03	Vegetables provisionally preserved in brine, in sulphur water or in other preservative solutions, but not specially prepared for immediate consumption	Placing in brine or in other solutions of vegetables falling within heading No. 07.01

BTN heading No.	Description	
07.04	Dried, dehydrated or evaporated vegetables, whole, cut, sliced, broken or in powder, but not further prepared	Drying, dehydration, evaporation, cutting, breaking, powdering of vegetables falling within heading Nos. 07.01 to 07.03 inclusive
08.12	Fruit, dried, other than that falling within heading Nos. 08.01, 08.02, 08.03, 08.04, or 08.05	Drying of fruit
15.04	Fats and oils, of fish and marine mammals, whether or not refined	Manufacture from products falling within Chapter 2

4. The requirements on BTN heading Nos. 21.04 and ex 39.02 have been amended to read:

Products obtained		Working or processing that confers the status of "originating" products when the following conditions are met
BTN heading No.	Description	
21.04	Sauces; mixed condiments and mixed seasonings	Manufacture from non-originating tomato concentrate, the value of which does not exceed 50% of the value of the product obtained
ex 39.02	Polymerization products	Manufacture in which the value of the non-originating products used does not exceed 50% of the value of the product obtained

Products obtained		Working or processing that confers the status of "originating" products
BTN heading No.	Description	
Chapters 28 to 37	Products of the chemical and allied industries	Working or processing in which the value of the non-originating products used does not exceed 20% of the value of the product obtained
ex Chapter 38	Miscellaneous chemical products excluding refined tall oil	Working or processing in which the value of the non-originating products used does not exceed 20% of the value of the product obtained
Chapter 39	Artificial resins and plastic materials, cellulose esters and ethers; articles thereof	Working or processing in which the value of the non-originating products used does not exceed 20% of the value of the product obtained
ex 79.01	Unwrought zinc	Manufacture from zinc waste and scrap
ex 80.01	Unwrought tin	Manufacture from tin waste and scrap

2. The working or processing operation required for BTN heading No. ex 40.07 has been amended to read: "Manufacture from vulcanized rubber thread or cord, not textile-covered".
