GENERALIZED SYSTEM OF PREFERENCES

Notification by Japan

Addendum

For the information of Contracting Parties, the Permanent Delegation of Japan has provided the following information on improvements to Japan's scheme of preferences.

Taking into consideration the important rôle the generalized system of preferences plays in the economic development of the developing countries and the wishes expressed by these countries, the Government of Japan introduced various improvements to its scheme on 1 April 1975 as described below:

1. Enlargement of the coverage of agricultural products (BTN Chapters 1-24)

With the addition of the six items listed below, the positive list of agricultural products (see Annex 3 to L/3876 and L/3876/Add.2) now covers seventy-six items at the BTN four-digit level compared to seventy-two items for the 1974 fiscal year.

(2) Selected Products falling within Chapters 25-99

The following selected product to which 50 per cent tariff reduction had applied previously, now enjoys duty-free import.

As a result, the number of items designated as selected products has been decreased from 48 to 47 at the BTN four-digit level.

3. Improvements in the administration of the ceiling

(1) Product groups

The number of product groups for the purpose of ceiling administration has been reduced from 182 for Fiscal Year 1974 to 177 for Fiscal Year 1975 (monthly control product group 125, daily control product group 41, prior allotment product group 11).

(2) Product groups qualifying for flexible administration of
the ceiling quotas

The number of product groups to which ceiling quotas are flexibly applied has been increased from 116 to 118 items, as a result of deletion of four groups through re-arrangement of items and addition of six new groups.

Note: The number of product groups to which maximum amount limitation for a beneficiary is not applied is now 122, as a result of addition, deletion and re-arrangement of items.
