Communication from the Commission of the European Communities  
to the CONTRACTING PARTIES

The following communication dated 28 October 1974 has been received by the secretariat.

I have the honour to advise you, for the information of the CONTRACTING PARTIES, that under a decision by the Commission of the European Communities the field of application of the deposit régime applied in Italy has been reduced with effect from 23 October 1974.

The attached list, valid as from 23 October 1974, includes all products for which the prior deposit has been eliminated since this measure was introduced on 7 May 1974. The list therefore supersedes earlier communications concerning amendment or elimination of the prior deposit (documents: L/4059, L/4065, L/4065/Add.1 and 2).
