## RESTRICTIONS ON IMPORTS FROM POLAND

### Notifications by Contracting Parties

#### Addendum

The following notifications have been received from the Governments of Canada, Finland and Romania.

#### Canada

Canada does not maintain restrictions on imports from Poland in the sense of paragraph 3 of the Protocol for the Accession of Poland.

#### Finland

The Permanent Mission of Finland has the honour to send enclosed statistics on the imports from Poland in 1973 of products which on 30 June 1974 were licence free when imported into Finland from countries under the multilateral import treatment but subject to licensing when imported from Poland.

As the mission has notified before (document L/4021 of 22 April 1974), according to decisions taken in March 1974 the following tariff headings were liberalized: 30.04, 42.02, 44.15.210/229, 44.18, 48.09, 53.08, 53.09, 53.12, 55.07, 58.07.010, 59.09, 59.10, 59.12, 59.16, 60.02, 60.06, 62.03, 62.05, 70.14.101/109, 73.11.015, 73.11.021/029, 73.40, 85.25, 96.02, 97.02/03 and 73.15 (except sub-heading 73.15.406: bars and rods, hot-rolled or extruded, of other alloyed steel).
