Notifications by Contracting Parties

Addendum

The following notifications have been received from the Governments of Iceland and Spain.

ICELAND

Iceland does not maintain any discriminatory restrictions against imports from Poland.

SPAIN

With reference to your airgram No. 1106, dated 1 July, I have pleasure in advising you, on instructions from my authorities, that Spain does not apply any discriminatory restrictions on imports from Poland.

In addition, and in compliance with the last paragraph of the note concerning restrictions on imports from Poland that is reproduced in the aforementioned airgram, I have pleasure in furnishing herewith photocopies of the relevant pages of Spain's foreign trade statistics, containing data of our imports from and exports to that country in 1973.
