## SCHEDULE III - BRAZIL

The following communication, dated 25 June 1975, has been received from the Brazilian delegation.

- 
1. I have the honour to inform you that the Brazilian Government, through Decree No. 75.772, dated 26 May 1975, and published on 27 May 1975, has put into effect, as of 27 May 1975, the Schedule III - Brazil of the General Agreement which resulted from the Article XXVIII renegotiations conducted under the decision by the CONTRACTING PARTIES of 27 February 1967, and subsequent extensions thereof.
  2. At the same time, I wish to inform you that the Brazilian Government considered it necessary to introduce the following modifications to Schedule III - Brazil, as renegotiated:

3. These modifications were made necessary and unavoidable in view of the significant changes that took place in the last few years in the global economic framework and in the Brazilian economy, especially in the industrial sector. Nevertheless they are not intended to restrict overall Brazilian imports, which have been increasing steadily, at a pace even greater than our exports. The Brazilian Government has thus acted to further the diversification of the Brazilian economy, in the spirit of Part IV of the GATT and, in the same spirit is approaching the interested contracting parties for consultations regarding the changes in Schedule III.
