SWITZERLAND

The situation regarding the régime applied to imports from Poland is as follows:

1. Industrial products

Taking into account the arrangements made to facilitate reciprocal trade in certain textiles products that are at present covered by specific provisions within the framework of GATT, imports from Poland into Switzerland of industrial products (finished and semi-finished products and primary products) are not subject to any quantitative restrictions.

2. Agricultural products

Imports of agricultural products from Poland are subject to the same régime as imports from all other countries. The special regulations in respect of eggs in the shell, which were applicable during the first six months of the year and were tantamount to a global quota, have been suspended on a trial basis as from 1 January 1975. Accordingly, imports of eggs are now unrestricted throughout the year.

Switzerland therefore applies no discriminatory quantitative restrictions in respect of Poland.

With reference to the request in the last paragraph of airgram GATT/AIR/1187, attached hereto are the statistics of Swiss imports from Poland for the years 1973-1974, broken down according to the Brussels Tariff Nomenclature.
