<u>SWEDEN - SURVEILLANCE LICENSING ARRANGEMENT</u> FOR CERTAIN TEXTILE PRODUCTS

The following communication, dated 10 December 1975, has been received from the Swedish Delegation.

I hereby have the honour to send you enclosed a notification concerning the introduction in Sweden of a surveillance licensing arrangement for certain textile products with the request that it be circulated to the contracting parties.

SWEDEN - TEXTILES SURVEILLANCE LICENSING ARRANGEMENT

A system of surveillance by means of a licensing arrangement will be introduced in Sweden as from 1 January 1976, for the importation from all sources of the textile items indicated below and not already subject to licensing. The purpose of this system, which does not involve any quantitative restrictions, is to supply information at an early stage on the development of imports of the products concerned.
