Additional Information

A. Policies and Government Measures

As Macao industrial policy has a non-interventionist character, it is not possible to characterize it properly by merely presenting specific measures related to concrete industry sectors.

Government action in this field mainly consists of the improvement of structural conditions for industrial development by overcoming several limitative factors which have discouraged investment.

Among these are elements related to transport and communications, professional training, electricity and water supply, availability of land for the establishment of industrial units, all aspects which show deficiencies and have been responsible for the non-materialization of some industrial projects that would be relevant for the diversification of Macao's industry.

As to the measures capable of exercising a direct effect over the sectorial orientation of investment, there is one which merits reference. This measure excludes from the distribution of free quotas (the parcel of quotas that the Administration reserves for the distribution among the exporters independently of their past performance) for a period of three years, the new enterprises in the textile and clothing sector. This measure favours the diversification of production in this area, and simultaneously works as a deterrent of the growth of the textile industry in its totality. The Government may also grant fiscal or other advantages - for instance, the concession of land on favourable conditions - in the case of industrial projects which have a special interest for Macao's economy. An important criterion of evaluation is the importance of the industrial project in question for the diversification of the Territory's industry.
