Subject: Notification under Article 11 of MFA

Dear Mr. Chairman,

I have the honour to inform you that Pakistan has not imposed any additional restrictions on import of textile and apparel since 1st January 1982. However, Pakistan has lifted the ban on import of cotton yarn.

I am further directed to enclose a list of textile items import of which is banned under the current Import Policy. This represents an exhaustive list of restraints on textiles and apparel. Import of all other textile and apparel items not indicated in the list is freely allowed.
