Page 4, Paragraph 3, third sentence: Philippine is misspelled twice. Sentence should read: By 1981, electrical machinery was the leading Philippine export to the United States while sugar had fallen to fifth place, and the total value of Philippine exports to the United States had exceeded \$1 billion.

Page 5, Paragraph 3, first sentence: Sentence should read: "Since the establishment of Part IV in 1966" vice 1968.
