ARRANGEMENT REGARDING INTERNATIONAL TRADE IN TEXTILES

Notification under Article 4:4

Modification of the Bilateral Agreement  
between the EEC and Romania

The Textiles Surveillance Body has received from the Commission of the European Communities a notification concerning a further modification of the bilateral agreement between the EEC and Romania, concluded under Article 4 of the MFA, introducing restraints on imports of knitted petticoats and slips (Category 69) into France.<sup>1</sup>

The TSB, pursuant to its procedures regarding bilateral agreements notified under Article 4<sup>2</sup>, has examined the relevant documentation and is forwarding the text of the notification to participating countries for their information.

AGREED MINUTE

1. Delegations of the Socialist Republic of Romania and the European Economic Community met at Brussels on 17 and 18 October 1983 for consultations in connection with the implementation of the bilateral EEC/Romania agreement on trade in textile products, initialled on 23 July 1982.

2. On the occasion of these consultations Romania agreed to limit its exports of petticoats and slips (Category 69 - Nimexe Code 60.04.54) to France from 1 January 1983 to 31 December 1986 to the following annual levels:

1983:	360,000 pieces <sup>1</sup>
1984:	374,000 pieces
1985:	389,000 pieces
1986:	405,000 pieces

3. It is agreed between the two parties that the provisions of the agreement concerning the export of products subject to quantitative limitations, and in particular the licensing procedures established under Protocol A to the agreement, shall apply to exports of the products mentioned above from 21 November 1983 onwards. From that date, the Romanian authorities shall issue export licences and certificates of origin up to the level of the limitations agreed on for exports to France of the products concerned.

4. In the context of the solution decided on for Category 69 the two parties have agreed on the following increases in the Category 73 quota for France for the years 1984 and 1986:

1984:	25,000 pieces
1985:	25,000 pieces
1986:	25,000 pieces
