ARRANGEMENT REGARDING INTERNATIONAL TRADE IN TEXTILES

Notification under Article 4:4

Modification of the Bilateral Agreement between the United States and Korea

The Textiles Surveillance Body has received a notification from the United States of a modification to their bilateral agreement with Korea, concluded under Article 4 of the MFA. Pursuant to the consultation provisions of the agreement, the United States elected to convert certain limits established for the 1984 agreement year, into specific limits for the 1985-1987 agreement years.¹

The TSB, pursuant to its procedures regarding bilateral agreements notified under Article 4², has examined the relevant documentation and is forwarding the text of the notification to participating countries for their information.

Dear Mr. Yu:

This letter refers to consultations between our Governments under paragraph 6 of our bilateral textile agreement during the 1984 agreement year. In accordance with paragraph 6(F) of the agreement, the Government of the United States has decided to convert the categories listed below into specific limit categories. Limits beginning with the 1985 agreement year are as follows:
