ARRANGEMENT REGARDING INTERNATIONAL TRADE IN TEXTILES

Notification under Articles 7 and 8

Modifications of the Bilateral Agreement between the EEC and China

The Textiles Surveillance Body has received a notification from the Commission of the European Communities concerning modifications of their bilateral agreement with China¹, introducing regional restraints on a number of categories during the period 1980-1983.

This notification has been made in accordance with the request by the Textiles Committee that agreements concluded with countries², non-participants in the Arrangement, should be notified.

The TSB is circulating the notification to participating countries for their information.

1. Delegations of the People's Republic of China and of the European Economic Community met several times in 1980-1982 in accordance with Article 6 of the Agreement between the European Economic Community and the People's Republic of China on trade in textile products.

2. As a result of these consultations, China agreed to limit on a regional basis its exports under the following categories to an annual restraint level as set out hereafter:
