#### ARRANGEMENT REGARDING INTERNATIONAL TRADE IN TEXTILES

### Notification under Article 4:4

### Amendment of the Bilateral Agreement between the United States and Indonesia

The Textiles Surveillance Body has received a notification from the United States of an amendment to their bilateral agreement with Indonesia, concluded under Article 4 of the MFA. The parties have agreed to specific limits with respect to Categories 317, 339, 369 pt (shop towels), 639 and 640.

The TSB, pursuant to its procedures regarding bilateral agreements notified under Article 4<sup>2</sup>, has examined the relevant documentation and is forwarding the text of the notification to participating countries for their information.

## UNITED STATES AND REPUBLIC OF INDONESIA AMEND BILATERAL TEXTILE AGREEMENT

The United States and the Republic of Indonesia amended their bilateral textile agreement by exchange of notes in Washington dated 25 February and 26 February 1985, respectively. Texts of the notes follow.

### UNITED STATES NOTE

Washington, 25 February 1985

His Excellency

Ambassador of the Republic of Indonesia

I have the honour to refer to the Arrangement Regarding International Trade in Textiles, with annexes, done at Geneva on 20 December 1973, and extended by Protocol adopted on 22 December 1981 at Geneva (hereinafter referred to as the Arrangement), to consultations between representatives of the Government of Indonesia and the Government of the United States in Jakarta on 17-19 January 1985 (hereinafter referred to as the consultations), and to the existing bilateral textile agreement of 1982, as amended, between the Republic of Indonesia and the United States (hereinafter referred to as the Agreement).

As a result of the consultations and in conformity with the Arrangement, I have the honour to propose amending the Agreement as follows:

1. That Annex B of the Agreement shall be amended to include the following specific limits and sub-limits.

2. Each of the above specific limits and sub-limits shall be prorated to reflect the following dates and limits.
