UNITED STATES AND SRI LANKA AMEND BILATERAL TEXTILE AGREEMENT

The United States and Sri Lanka exchanged letters in Colombo to effect amendment to their bilateral textile agreement. Texts of the letters dated 31 May and 14 June 1985, respectively, follow.

UNITED STATES LETTER

Colombo, 31 May 1985

The Honourable M.S. Amarasiri Minister of Trade and Shipping Colombo

Dear Mr. Minister

I have the honcur to refer to the exchange of notes between the Government of the Democratic Socialist Republic of Sri Lanka and the Government of the United States dated 26 February and 20 March 1985 regarding the textile agreement between our governments of 10 May 1983 (hereinafter referred to as the Agreement).

I wish to propose that we amend and extend the terms of the exchange of notes to correspond with the existing bilateral agreement.
