Attached is a report received by the Textiles Surveillance Body from Norway concerning the present status of its restrictions on trade in textiles and clothing. This report has been submitted in accordance with Article 11 of the Arrangement, and in particular paragraphs 11, 12 and 2 thereof. This notification also fulfills Norway's obligations under Article 2:4.

Letter to Chairman, TSB from Permanent Mission of Norway

Geneva, 19 July 1985

Dear Mr. Raffaelli,

Referring to your letter of 2 May 1985, I am pleased to inform you as follows:

As of 1 July 1985, Norway had concluded bilateral agreements based on MFA's Article 4 with the following participants: Czechoslovakia, Hong Kong, Hungary, India, Korea, Macao, Malaysia, the Philippines, Poland, Romania, Singapore, Sri Lanka, Thailand and Yugoslavia. All of these agreements have been, or will be, in the near future, notified to the Textiles Surveillance Body. Moreover, a bilateral MFA agreement with China which was initialled on 3 June 1985, is intended to enter into effect on 1 January 1986. For the second half of 1985, in accordance with a Memorandum of Uncerstanding attached to that agreement, a transitional régime based on import licensing was agreed upon. This régime has the same product coverage and number of quotas as the bilateral agreement. The agreement, as well as the MOU, will be notified to the TSB in due course. As of 1 July 1985, there existed no other Norwegian quantitative restrictions on imports of textile products covered by the MFA towards MFA participating countries. The transitional measures notified under MFA's Article 2:1 in COM. TEX/SB/1007 had been phased out by 1 July 1985, c.f. COM.TEX/27/Add.12, page 3. This should also fulfill the notification requirements of MFA's Article 2:4.

As to the notification requirements of Articles 7 and 8, I have the honour of informing you of the fact that Norway presently maintains import restrictions on products covered by the MFA towards the following non-participants: the German Democratic Republic and Malta. Whereas the Norwegian restrictions towards the German Democratic Republic are unilateral (see the enclosed P.M. of 10 July 1985), there is a bilateral agreement with Malta, modelled on the Norwegian MFA agreements. Please find enclosed a copy of this agreement. Basically, the restrictions towards the two non-MFA participants involve the same product coverage as those in the bilateral MFA agreements concluded by Norway.

The Royal Ministry of Trade and Shipping has the honour of referring to the meetings with the Embassy of the German Democratic Republic on 26 June and 8 July 1985. During the period of 1 July 1985 to 31 December 1986, the following régime will apply for certain textile products of GDR origin when imported into Norway:
