## Modification of the Bilateral Agreement between the United States and Singapore

The Textiles Surveillance Body has received a notification from the United States of a further modification of its bilateral agreement with Singapore, concluded under Article 4 of the MFA. The parties agreed to an increase in the 1985 consultation level for Category 342 (cotton skirts).

The TSB, pursuant to its procedures regarding bilateral agreements notified under Article 4<sup>2</sup>, has examined the relevant documentation and is forwarding the text of the notification to participating countries for their information.

### UNITED STATES AND SINGAPORE AMEND BILATERAL TEXTILE AGREEMENT

The United States and Singapore exchanged letters in Washington dated 15 August and 30 August 1985, respectively, to effect amendment of their bilateral textile agreement. Texts of the letters follow.

### UNITED STATES LETTER

Dear Mr. Choo

I am writing with reference to paragraph 5 of the agreement between the United States and Singapore relating to trade in cotton, wool and man-made fibre textiles and textile products, with annexes, effected by exchange of notes 21 August 1981, as amended ("the Agreement") and to your government's request of 17 July to increase the consultation level for Category 342 - cotton skirts.

On behalf of my government, I propose the following designated consultation level (DCL) be established for 1985.

Category	Current MCL Level	Proposed DCL
342	39,326 dozen	50,000 dozen

If this proposal is acceptable to your government, this letter and your letter of confirmation on behalf of your government shall constitute an amendment to the Agreement.
