PROPOSALS REGARDING QUANTITATIVE RESTRICTIONS AND OTHER NON-TARIFF MEASURES

New Zealand

The report (1985) of the Group on Quantitative Restrictions and Other Non-Tariff Measures, adopted by the CONTRACTING PARTIES at their forty-first session, contains the recommendation that contracting parties, following on the submissions already presented in 1985 (NTM/W/12 and Addenda), should make specific written proposals by the end of April 1986 directed towards the achievement of the objectives laid down by Ministers (L/5888, paragraph 49).

The following communication, dated 28 April 1986, has been received from the Permanent Mission of New Zealand.

In accordance with the requirement on Contracting Parties to submit a notification by the end of April concerning quantitative restrictions maintained by them, I have pleasure in advising that the attached list of 150 items represent deletions that should be made from the comprehensive list contained in NTM/W/12/Add.8. All these items have been made exempt from import licensing since 1 July 1985.

In all cases the exempt items are identified by their CCCN heading, together with a full description. The date on which they were made exempt is included also.

With the exception of these items made exempt already, New Zealand's proposals to achieve the liberalization and elimination of quantitative restrictions and the liberalization of other non-tariff measures remain those detailed in NTM/W/12/Add.8.
