Note by the Secretariat

Addendum

1. In its Report (1984) (BISD 31S/211), adopted by the CONTRACTING PARTIES at their fortieth session, the Group on Quantitative Restrictions and Other Non-Tariff Measures recommended that the documentation on quantitative restrictions be kept up-to-date on a regular basis through notifications by contracting parties maintaining the measures (paragraph 44(a)).

2. In its Report (1986) (L/6073, paragraph 28), adopted by the CONTRACTING PARTIES at their forty-second Session in their Decision establishing the Technical Group (L/6100), the Group on Quantitative Restrictions and Other Non-Tariff Measures called upon contracting parties to supply to the secretariat before 31 January 1987 information lacking in the documentation, including full GATT justification for the measures that they maintain. It also requested them to inform the secretariat by the same date of any specific amendments they wished it to make to the existing basic documentation and analyses.

3. This document contains information additional to that included in NTM/W/6/Rev.3 and Rev.3/Add.1-5. It is organized as follows:

- I. Amendments to the country notes relating to Brazil and Norway.
- II. Table of quantitative restrictions: up-dated information relating to Brazil and Norway.

I. Amendments to Country Notes

BRAZIL

NORWAY

Replace 1986 by 1987 after "Notification to the Group".

II. Table of quantitative restrictions

4. The tables of NTM/W/6/Rev.3 should be up-dated to take into account the following notifications from Brazil and Norway.

BRAZIL

In the up-dating of the tables of NTM/W/6/Rev.3 in line with the notification contained in L/6126, document L/6126/Corr.1 of 18 February 1987 should also be taken into account.

NORWAY

The following communication, dated 16 February 1987, has been received from the delegation of Norway.

I have the honour to transmit enclosed a complete list of products to which non-tariff measures apply when imported into Norway, covering the chapters 25-99 of the CCCN.

The previously notified state trading (ST) for some pharmaceutical products has been deleted from the list of measures since this trade entails no restrictive effect and therefore cannot be notified under the new nomenclature as state trading restrictions (STR). I also wish to note that automatic licensing (AL) entails no restrictive effect.

For products covered by the MFA reference is made to documentation under that agreement. The documentation on agricultural products will be up-dated in the context of the Uruguay Round.
