### ARRANGEMENT REGARDING INTERNATIONAL TRADE IN TEXTILES

#### Notification under Article 4:4

#### Amendment of the bilateral agreement between the United States and Bangladesh

The Textiles Surveillance Body received a notification from the United States of a further amendment of its bilateral agreement with Bangladesh. Specific limits were agreed on Categories 338/339 (cotton knit shirts), 342/642 (cotton and man-made fibre skirts) and 638/639 (man-made fibre knit shirts).<sup>1</sup> The agreed restraint on Category 338/339 superseded a unilateral measure taken by the United States under Article 3:5.

The TSB, pursuant to its procedures regarding notifications made under Article 4,<sup>2</sup> has examined the relevant documentation and is forwarding the text of the notification to participating countries for their information.

UNITED STATES AND BANGLADESH AMEND  
BILATERAL TEXTILE AGREEMENT

The United States and Bangladesh amended their Bilateral Textile Agreement by exchange of notes on October 6 and October 9, 1987. Text of the notes follow:

UNITED STATES NOTE

October 9, 1987

The Secretary of State presents his compliments to His Excellency the Ambassador of Bangladesh and refers to the Agreement between the Government of Bangladesh and the Government of the United States of America relating to trade in certain apparel categories effected by exchange of Notes on February 19 and February 24, 1986, and amended by exchange of Notes on March 25 and March 27, 1987. The Secretary of State has the further honor to refer to consultations held in Washington, September 14-17, 1987 between the Governments of the United States and the People's Republic of Bangladesh concerning Bangladesh exports of apparel to the United States.

On behalf of the Government of the United States of America, the Secretary proposes that the Agreement shall be amended to establish the Specific Limits listed below:

The conversion factor for special shift and swing in Category 638/639 will be 15.5 square yards per dozen. Swing of 6 percent shall be available. Carryforward of 6 percent will be available, except in the final Agreement Year. Carryover of 11 percent shall be available, except in the first Agreement Year. The combination of carryover and carryforward shall not exceed 11 percent in any one Agreement Year.

If the foregoing proposal is acceptable to the Government of the People's Republic of Bangladesh, then this note and a note of confirmation from his Excellency on behalf of the People's Republic of Bangladesh shall constitute an amendment to the Agreement.

BANGLADESH NOTE

Excellency,


I have the honour to refer to the Department of State's Note Verbale of September 29, 1987 concerning the Agreement between the United States of America and the People's Republic of Bangladesh pertaining to trade in certain categories pursuant to discussions held between representatives of our Governments in Washington September 14 - 17, 1987.

I wish to clarify that it is the understanding of the Government of Bangladesh that the agreement shall be amended to establish the specific limits as listed below:

I wish also to clarify that the conversion factor to be used for special shift and swing in Category 638/639 shall be 15.5 square yards per dozen. If these clarifications are acceptable to the United States then the Government of Bangladesh confirms that the proposed amendment conforms to the understanding reached between the People's Republic of Bangladesh and the United States. This note and the note of U.S. confirming this clarification will constitute an amendment to the agreement.
