ARRANGEMENT REGARDING INTERNATIONAL TRADE IN TEXTILES

Notification under Article 4:4

Amendment of the bilateral agreement  
between Finland and Macao

The Textiles Surveillance Body received a notification from Finland of an amendment to its agreement with Macao. New restraints were agreed for the duration of the agreement effective from 1 January 1988.

The TSB, pursuant to its procedures regarding notifications made under Article 4,<sup>2</sup> has examined the relevant documentation and is forwarding the <sup>3</sup> text of the notification to participating countries for their information.

AGREED MINUTES

During the consultations held in Geneva on November 18 and 19, 1987 between a delegation from Finland and a delegation from Macau on imports of textiles from Macau to Finland and having regard to the Arrangement regarding International Trade in Textiles, to the Protocol extending the said Arrangement signed on July 31, 1986 and to Articles 8 and 9 of the Memorandum of Understanding signed between Finland and Macau on 15 of November 1986, agreement was reached as follows:

1. The following amendments to the present Memorandum of Understanding between Finland and Macau, signed on 15 of November 1986 shall apply from January 1, 1988.
2. Annex I of the present Memorandum of Understanding is replaced by Annex I to these Agreed Minutes the amendments taking effect on 1 January 1988.
3. Annex II of the present Memorandum of Understanding is replaced by Annex II to these Agreed Minutes the amendments taking effect on 1 January 1988.
4. Annexes I and II of these Agreed Minutes are based on the Tariff Classification numbers resulting from the introduction of the Harmonized Commodity Description and Coding System introduced by Finland as from 1st of January 1988.
5. In case of any reclassification concerning a product declared in an Export Licence issued by the Government of Macau, the Government of Macau, the Government of Finland will notify the government of Macau, and will not allow the customs clearance nor charge it to any restraint limit unless a new Export Licence with the correct category is issued.
