The Permanent Mission of the Socialist Federal Republic of Yugoslavia to the United Nations Office and Other International Organizations in Geneva presents its compliments to the GATT Secretariat and has the honour to transmit the Yugoslav Government notification by virtue or Article 11 of MFA and item 24 of the Protocol on Extention (1986). Further to that we wish to stress that the data in columns 6 i 7 of the enclosed document cover the first half of this year, since Yugoslavia has applied the Harmonized System since 1 January 1988.

The export/import values are denominated in YU dinars, calculated at the current mean exchange rate for the US dollar. Namely, the conversion of value was applied to every single customs declaration at the prevailing rate on the date of customs clearance of the imported goods.

The Permanent Mission of Yugoslavia avails itself of this opportunity to renew to the GATT Secretariat the assurances of its high consideration.
