#### Addendum

1. Following the decision by the Group at its meeting of 14 September 1988 (L/6397, paragraph 18), notifications received by 30 November 1988 have been consolidated in document NTM/W/6/Rev.5. The document is in two parts, one in the Customs Cooperation Council Nomenclature (CCCN), one in the Harmonized System (HS). The present addendum includes notifications received more recently.
2. This document is organized as follows:
  - I. Amendments to country notes relating to Argentina, Brazil, Canada, Finland, Hungary, India, Morocco, Norway, Sweden and the United States.
