ARRANGEMENT REGARDING INTERNATIONAL TRADE IN TEXTILES

Notification Under Article 4

Amendment of the Bilateral Agreement  
Between Norway and Hungary

The Textiles Surveillance Body received a notification from Norway of modifications of its Agreement with Hungary. Restraints on three product categories were liberalized,<sup>1</sup> and all products subject to consultation were deleted from the Agreement.

The TSB, pursuant to its procedures regarding notifications made under Article 4,<sup>2</sup> has examined the relevant documentation and is forwarding the text of the notification to participating countries for their information.

Agreed Minute

1. Delegations from the Hungarian People's Republic and the Kingdom of Norway met in Budapest on 19-20 September 1988 for consultations in accordance with paragraphs 19 and 15 of the Agreement relating to the exports from the Hungarian People's Republic of certain textile products for imports into Norway, signed in Budapest on 9 March 1988.

2. As a result of these consultations the Parties agreed on the text of the Amendments (Annex 1) which should be enclosed to the above-mentioned Textile Agreement.

Amendments to the Agreement Relating to Exports From the  
Hungarian People's Republic of Certain Textile Products  
for Imports into Norway

During consultations held in Budapest 19-20 September 1988 in accordance with Articles 19 and 15 of the Agreement, Norway and Hungary agreed to the following amendments:

I. In Annex A (Product categories covered by the Agreement) delete:

"9	Pairs	Stockings, understockings, socks, ankle socks, sockettes and the like, knitted or crocheted, not elastic nor rubberized, except women's stockings, and thick woollen socks (known as "raggsokker")	60.03.120-.190 60.03.920, -.949 -.990)
10	Pieces	Women's and girls' outer garments of woven material: - dresses, housecoats, frocks and gowns	61.02.342, -.352, -.362 and -.392 ex 61.02.941, -.951, -.961 and -.991
11	Pieces	Other garments of woven material, women's, girls': - skirts, including divided skirts	61.02.440-.490
13	Pairs	Gloves, mittens and mitts of textile material, not knitted or crocheted	61.10.010-.029

II. In Annex B (Restraint levels) delete categories 13, 23 and 25.

III. As a consequence of the deletions in Annex A delete also paragraph 8 of the Agreement ("Products covered by the Agreement without restraint levels") and the reference which is made to this paragraph in the MOU of 9 March 1988, i.e. section three on page one.

IV. As of 1 January 1988 Norway changed its tariff classification from the old CCC-nomenclature to the Harmonized Commodity and Coding System. As a consequence of this, exchange the CCC-numbers in Annex A thus:
