ARRANGEMENT REGARDING INTERNATIONAL TRADE IN TEXTILES

Notification under Articles 7 and 8

Regulations on imports into Norway from the German Democratic Republic

The Textiles Surveillance Body received a notification from Norway of regulations on imports of certain textile products originating in the German Democratic Republic for the period 1 January 1989 to 31 December 1989.¹

The notification has been made in accordance with the request of the Textiles Committee that actions taken vis-à-vis non-participants be notified; the TSB is forwarding the text of the notification to participating countries for their information.
