YUGOSLAVIA - REVISED SCHEDULE OF CONCESSIONS

On 4 October 1989, the Committee of Participating Countries took note that in the light of the consultations undertaken among interested participating countries no objections existed to the revised schedule of concessions of Yugoslavia which had been circulated in document CPC/97. The Committee agreed that the schedule of concessions of Yugoslavia revised in accordance with the Harmonized Commodity Description and Coding System should be included in a certification of rectifications to schedules. The revised schedule of concessions of Yugoslavia is reproduced hereunder.
