#### THAILAND

Attached is a report received from Thailand on the status of restrictions maintained by it on imports of textile products covered by the Arrangement as extended by the 1986 Protocol. This report has been submitted in accordance with Article 11, paragraphs 11, 12 and 2 of the MFA.<sup>2</sup>

After its review, the TSB agreed to forward the notification to participating countries, together with its comments and recommendation.<sup>3</sup>
