## TEXTILES AND CLOTHING - TRADE STATISTICS

The statistics in this document cover the years 1985 to 1989. They are presented in three sections. Section 1 summarizes trade in textiles and clothing for all members of the MFA for which data are available. Detailed statistics on the imports of textiles and clothing into each developed member of the MFA broken down by areas and countries of origin, expressed in dollar values and percentage shares are also presented. Section 2 focuses on trade in cotton textiles. Section 3 covers trade in wool textiles.

The Secretariat has also prepared annual statistics on trade in textiles and clothing by origin and destination for all members who report trade data to the UN Statistical Office. These statistics are available to delegations on request.

EXPLANATORY NOTES

The trade data have been extracted from the United Nations Statistical Office COMTRADE database.

The textile and clothing aggregates are based on the SITC<sup>1</sup>. The switch-over to the latest revision (rev.3) of that classification, which began with data from 1988 inclusive, made it necessary to revise the definitions of the textile and clothing aggregates followed by the Secretariat. This was done by modifying the previous definitions of textiles and clothing to coincide as closely as possible to the SITC rev.3. In this way, the disruption in the continuity of the data with respect to time series for individual members as well as between member countries has been minimized. The effect of these revisions on the continuity of the data series can be illustrated taking the import data of the United States as an example.

Neither the old definition, nor the new definition of textiles and clothing fully reflect the product coverage of the MFA.

The switch-over to the SITC rev.3 has also affected the extent to which trade in products of cotton and wool in Sections 2 and 3 can be reasonably documented. Previously, the aggregates for cotton and wool textiles and clothing were based on the addition of selected 4 or 5 digit SITC rev.2 items. With the switch-over to the SITC rev.3, (it is now the classification in which trade of all the developed members is reported to the UNSO comtrade data base) much of the comparability with the earlier version of the SITC at this level has been lost. For example, trade in clothing in the SITC rev.3 is no longer broken down by fibre so that the cotton and wool clothing aggregates can no longer be compiled. Regarding textiles, the product coverage of the aggregates has had to be narrowed down in order to maintain a more or less comparable time series.

Cotton yarn refers to SITC rev.3 sub-groups 651.2 and 651.3. Woven cotton fabrics refer to SITC rev.3 group 652. Wool tops refer to SITC rev.3 sub-group 268.73. Wool yarn refers to SITC rev.3 sub-group 651.1, and woven wool fabrics refer to SITC rev.3 sub-groups 654.2 and 654.3.

Values are in current US dollars. Exports are valued f.o.b.; imports are in c.i.f. values, with the exception of Canada, Czechoslovakia and Poland for which imports are expressed in f.o.b. values.

Data for the European Communities refer to the twelve member States as listed below, and exclude intra-community trade. The statistics are aggregated from individual member States' submissions which are not strictly comparable with regard to definitions of trade (special/general) and of countries of origin (provenance) and destination.

The Chinese data are taken from "China's Customs Statistics", denominated in RMBY. They have been converted to dollars by means of the United Nations Trade conversion factors. Textiles and clothing refer to SITC Rev.2 divisions 65 and 84, unadjusted for non-MFA products.

The area definitions of trading partner countries listed below follow those adopted in previous reports. The membership of the Arrangement is as at 30 September 1990.
