#### ARRANGEMENT REGARDING INTERNATIONAL TRADE IN TEXTILES

##### Notification transmitted under Article 4

##### Extension and amendment of the bilateral agreement between Canada and the Czech and Slovak Federal Republic

The Textiles Surveillance Body received a notification from Canada of the extension and amendment of its bilateral agreement with the Czech and Slovak Federal Republic for the period 1 January to 31 December 1992.<sup>1</sup>

The TSB had received the notification under Articles 7 and 8 when the Czech and Slovak Federal Republic had not accepted the extension of the 1986 Protocol. By the time of review, the Czech and Slovak Federal Republic had accepted the extension.

The TSB has therefore decided to review the notification in accordance with its procedures for notifications received under Article 4.<sup>2</sup> The TSB has examined the relevant documentation and is forwarding the text of the notification to participating countries for their information.

CANADA - CZECHOSLOVAKIA CONSULTATIONS

AGREED RECORD OF DISCUSSIONS, 18 DECEMBER 1991

1. Delegations representing the Government of Canada and the Government of the Czech and Slovak Federal Republic met on 17-18 December 1991, in Prague to discuss the extension of the Arrangement between the Government of the Czech and Slovak Federal Republic and the Government of Canada relating to the export from Czechoslovakia of certain textiles and textile products for import into Canada (the Arrangement).
2. During these discussions, it was agreed that the Arrangement would be extended for one year beyond its current date of expiration of 31 December 1991, and that accordingly it would remain in effect for the period of 1 January to 31 December 1992.
3. For the period of extension of the Arrangement during 1992, the attached Annex would replace Annex I of the original Arrangement.
4. The agreement on extension of the Arrangement would be without prejudice to any conclusions which may be reached respecting international trade in textiles and textile products in the framework of the Multilateral Trade Negotiations (the Uruguay Round).
