Notification under Article 4:4

Extension and amendment of the bilateral agreement between Norway and Hungary

The Textiles Surveillance Body received a notification from Norway of an extension and amendment of its bilateral agreement with Hungary for the period 1 January 1992 to 31 December 1993.

AGREED MINUTES

- 1. Delegations from the Kingdom of Norway and the Republic of Hungary met in Budapest on 8-9th of April, 1992 for consultations in accordance with Articles 19 and 15 of the Agreement relating to the exports from the Republic of Hungary of certain textile products for imports into Norway, signed at Budapest on 9th of March, 1988.
- 2. As a result of these consultations it was agreed to initial the enclosed amendments to the Textile Agreement as previously amended.

AMENDMENTS

Amendments to the Agreement between the Government of the Kingdom of Norway and the Government of the Republic of Hungary relating to the exports from Hungary of certain textile products for imports into Norway, signed at Budapest on 9th of March, 1988

- I. The Government of the Kingdom of Norway and the Government of the Republic of Hungary have agreed to the following amendments to the Textile Agreement:
 - (i) Throughout the Agreement the term "Hungarian People's Republic" is replaced by the term "Republic of Hungary".
 - (ii) In Article 2, after "as extended by the Protocol of 31.7.1986" add "and as further extended by the Protocol of 31.7.1991".
 - (iii) Delete Article 7, paragraph (d) on total flexibility.
 - (iv) In Article 18, second line, delete "1991" and replace it with "1993".
 - (v) Replace the existing Annex A on product coverage, with the attached Annex A.
 - (vi) Replace the existing Annex B on restraints, with the attached Annex B.
- II. These amendments take effect as of 1st of January, 1992.
