Reference to column "HS No. or other categorization":

It should be noted that the Austrian Customs Tariff 1988 (published in the Federal Gazette No. 155/1987) is based on the International Convention on the Harmonized Commodity Description and Coding System (published in the Federal Gazette No. 553/1987). The bilateral agreements concluded after this date already take into account the Harmonized System Nomenclature. The agreements concluded earlier are still based on the CCCN. Therefore, it will be necessary to transpose the earlier agreements into the Harmonized System, as far as Harmonized System heading Nos. and product descriptions are concerned, without any change in the substantive content of these agreements. This will be done by means of exchange of letters with the contracting parties concerned. Austria reserves, therefore, her right of further relevant notifications.
