#### Notification under Article 11

Report on the Status of Restrictive Measures  
as requested by the TSB in accordance with Article 11<sup>1</sup>

#### EUROPEAN ECONOMIC COMMUNITY

Attached is a report received from the EEC on the status of restrictions maintained by it on imports of textile products covered by the Arrangement as extended by the 1986 Protocol. This report has been submitted in accordance with Article 11, paragraphs 11, 12 and 2 of the MFA.<sup>2</sup>

Dear Ambassador,

In compliance with your request mentioned in your letter (TS/140-1.1 of 23 December 1991) referring to the TSB decision of 9 December 1991 and pursuant to Article 11, paragraphs 2, 11 and 12 of the Arrangement, I have the honour to inform you that the EEC has introduced modifications to the measures it applies on textile products vis-à-vis some countries:

1. The provisions of the Agreement between the Community and the USSR on trade in textile products initialled on 1 December 1989 are no longer applicable to textile products originating in the Republics of Estonia, Latvia and Lithuania. Since 11 March 1992 (cf Council Regulations (EEC) n° 601/92), the following categories are subject to a prior surveillance system: Cat. 1, 2, 2(a), 3, 4, 5, 6, 7, 8, 20, 21, 9, 22, 23, 39, 12, 13, 15, 16, 24, 26/27, 29, 73, 83, 33, 36, 37, 50, 67, 74, 90, 115, 117, 118.
2. Imports of certain textile products originating in Albania are also subject to a prior surveillance system (same Regulation, same date of entry into force, same product coverage as above). This surveillance system has replaced restrictions which were notified on 3 August 1990.<sup>1</sup>
3. There are no more restrictions maintained on textile imports from the German Democratic Republic following the German unification. They had been first suspended with effect from 1 July 1990 and then eliminated.
4. Restrictions are still maintained by the EC on Mongolia, North Korea and Vietnam: see list attached.
