NOTIFICATION UNDER PARAGRAPH 3 OF THE DECLARATION ON TRADE MEASURES TAKEN FOR BALANCE-OF-PAYMENTS PURPOSES

Communication from South Africa

The following communication, dated 5 January 1993, has been received from the Permanent Mission of South Africa.

"I have the honour to refer to South Africa's communication in document L/5898 of 31 October 1985 and document L/5898/Add.1 of 7 September 1988, notifying the contracting parties of its decision to introduce surcharges.

The rates of surcharge have, in the meantime, been adjusted downwards in line with South Africa's undertaking to phase out the surcharge. In view thereof, the relevant rates of surcharge are hereby amended by the substitution for L/5898/Add.1 of the attached extract for the South African Customs and Excise Act, namely Part 4 of Schedule No. 1.

As stated at the last Council meeting South Africa would be prepared to consult with contracting parties on these measures in the Committee on Balance-of-Payments Restrictions."

- 1. The rate of surcharge specified in this Part in respect of any imported goods (excluding goods provided for in Note 7) shall apply to any such goods at the time of entry for home consumption in terms of Schedule No. 1, 3 or 4.
- 2. The value for surcharge purposes shall be the value for customs duty purposes as defined in Section 65(1).
- 3. Any surcharge payable in terms of this Part in respect of any goods specified therein shall be additional to any customs or excise duty payable in terms of Part 1 or 2 in respect of such goods.
- 4. Imported goods shall not be declared on separate bills of entry for the purposes of Parts 1, 2 and 4 of this Schedule.
- 5. Where the tariff heading or sub-heading under which any goods are classified in Part 1 of this Schedule is expressly quoted in this Part, it shall be deemed not to include goods which are not classified under the said tariff heading or sub-heading.

Any reference in this Part to a tariff heading comprising two digits followed by a point and two noughts (e.g., 01.00) shall, for the purposes of Note 5 to this Part, be construed as referring to all tariff headings in Part 1 of this Schedule, the first two digits of which correspond to the two digits referred to in this Part.

(a) Notwithstanding the provisions of Note 7(k), the amount of 1542 surcharge withdrawn in terms of any permit issued by the Director-General: Trade and Industry under the provisions of the said Note, shall remain due and shall constitute a debt to the State by the person to whom the permit is issued and as security for such debt the capital goods imported in terms of such permit, shall be subject to a lien under the provisions of Section 114 which shall apply mutatis mutandis from the time such capital goods are entered for home consumption until the said Director-General certifies that the conditions specified in such permit have been complied with, or, if the said Director-General withdraws such permit and the surcharge withdrawn has been paid in full to the Commissioner: Provided that the Commissioner may at any time require any other security or additional security in the amount and in the form as he may determine;
 - (b) Such capital goods shall be subject to such lien as if 1542 detained in accordance with the provisions of Section 114(2);
