Re: Fiji - Restrictions Maintained on MFA Products

We acknowledge receipt of your faxed letter dated 8 March 1993 re the request for additional information on other MFA products.

This is to confirm that all other MFA products (yarns/fabrics/made-up garments) are not under any restraint or quantitative restrictions. The import duties on yarns and fabrics are 10 per cent while duties on made-up products are 25 per cent.

We sincerely hope that this information together with that contained in our earlier letter of 5 November 1992 will now enable the TSB to determine whether Fiji has fulfilled its obligation under Article 2:1 of the Arrangement.

Re: Fiji - Restrictions under the Multi-fibre Arrangement

In accordance with the obligation emanating from Fiji's accession to the Arrangement on the International Trade in Textiles in June 1991 you are hereby kindly informed that the Fiji government presently does not impose any restraint or quantitative restriction on garments imported into or exported from the country.

The tariffs applicable on all categories of garments are generally low and range from duty-free to 25 per cent while tariffs on textile fabrics are set at 10 per cent.

I sincerely hope this formal notification has sufficiently addressed our pending obligations under the Arrangement.
