This confirms that, as discussed in the recent consultations between us, my government has decided that, in view of the current situation with respect to imports into the United States of men's and boys' wool suits, the United States will revoke the existing restraint for Category 443 in respect of Brazil.

This action is being undertaken on the understanding that it is without prejudice to either party's positions with respect to questions addressed by the Textiles Surveillance Body in its consideration of this issue, or the rights and obligations of either party under the MFA and the US/Brazil bilateral agreement.

Dear Commissioner,

Effective on 2 June 1993, this directive cancels the limit established in the directive issued to you on 12 March 1993, by the Chairman, Committee for the Implementation of Textile Agreements, for wool textile products in Category 443, produced or manufactured in Brazil and exported during the twelve-month period which began on 1 April 1993 and extends through 31 March 1994. Textile products in Category 443 shall remain subject to the aggregate limit for the 1 April 1993 through 31 March 1994 restraint period.

The Committee for the Implementation of Textile Agreements has determined that this action fall within the foreign affairs exception to the rulemaking provisions of 5 U.S.C.553(a)(1).
