## Memorandum on the Foreign Trade Régime

## Addendum

The following communication from the Representation of Chinese Taipei was received on 16 June 1994.

Pursuant to the Additional Note 7 to Chapter 29 of our Customs Import Tariff Schedule, my Government has adjusted the import tariff rates of some products under ten HS tariff lines in that Chapter. Enclosed please find a list containing the HS numbers and description of the products concerned (which will be ex-out items) as well as the text of the above-mentioned note.

Please note that this tariff rate adjustment has become effective as from 27 April 1994. The first column tariff rates (i.e. Non-MFN Rates) for the products concerned were hence raised from 2.5 per cent to 12.5 per cent, while the second column tariff rates (i.e. MFN Rates) for the same products were increased from 0 per cent to 10 per cent.
