**ARRANGEMENT REGARDING INTERNATIONAL TRADE IN TEXTILES**

**Notification under Article 4:4**

**Extension and amendment of the agreement between  
Norway and Macau**

The Textiles Surveillance Body received a notification from Norway of an extension with amendments of its agreement with Macau for the period 1 January 1994 to 31 December 1995.<sup>1</sup>

The TSB, pursuant to its procedures regarding notifications received under Article 4,<sup>2</sup> has examined the relevant documentation and is forwarding the text of the notification to participating countries for their information.

**AGREED MINUTES**

1. Delegations from the Government of the Kingdom of Norway and the Government of Macau met in Oslo on 12-13 August 1993 for consultations in accordance with Articles 15 and 17 of the Agreement between the Government of the Kingdom of Norway and the Government of Macau relating to the exports from Macau of certain textile products for imports into Norway, signed at Macau on 6 April 1988.
2. As a result of these consultations it was agreed to initial the enclosed amendments to the Textile Agreement as previously amended.

**AMENDMENTS TO THE AGREEMENT BETWEEN THE GOVERNMENT OF  
THE KINGDOM OF NORWAY AND THE GOVERNMENT OF MACAU  
RELATING TO THE EXPORTS FROM MACAU OF CERTAIN TEXTILE PRODUCTS  
FOR IMPORTS INTO NORWAY, SIGNED AT MACAU ON 6 APRIL 1988.**

I. The Government of the Kingdom of Norway and the Government of Macau have agreed to the following amendments to the Textile Agreement as previously amended:

(i) In Article 2, after "as further extended by the Protocol of 31.7.1991", add "and the Protocol of 9.12.1992".

(ii) Replace Article 3 by the following text:

"3. This Agreement shall apply for the period 1 January 1988-31 December 1995. However, if the Agreement on trade in textiles and clothing products resulting from the Uruguay Round GATT trade negotiations is concluded and enters into force at an earlier date, this Agreement shall be automatically terminated as of the date agreed for the implementation of the results of the Uruguay Round GATT trade negotiations."

(iii) Replace the existing Annex A on product coverage, with the attached Annex A.

(iv) Replace the existing Annex B on restraints, with the attached Annex B.

II. These amendments take effect as of 1 January 1994.

**PRODUCT CATEGORIES COVERED BY THE AGREEMENT**

Pieces	Outer garments of woven material, men's, boys' women's, girls':  - Jackets, tailored jackets, blazers, waistcoats, sports jackets (including parts of ski suits), anoraks and similar garments, parkas, one-piece suits and the like, also as parts of suits, sets and costumes (boys and girls with height above 152 cm).
2.	Pieces	Outer garments of woven material, men's, boys', women's, girls':  Trousers, slacks, jeans, breeches and the like (including bib and brace overalls), other than swimwear and shorts, also as parts of suits and sets (boys and girls with height above 152 cm).
