TS/140-1.1, dated 18 May 1994, inviting the submission of information from participating countries on restrictions maintained by them on textile products covered by the Arrangement, I wish to inform you that Macau applies no restrictions to trade in textiles, except on exports covered by bilateral agreements between Macau and certain importing countries under the provisions of the MFA.
