#### Communication from South Africa

The following communication, dated 24 August 1994, has been received from the Permanent Mission of South Africa.

I have the honour to refer to South Africa's notification under paragraph 3 of the Declaration on Trade Measures taken for Balance-of-Payments Purposes as contained in L/5898 and Add.1 and Add. 2 and to inform you of the following:

In pursuance of South Africa's commitment to further phase out the surcharge and in accordance with its undertaking to the Committee on Balance-of-Payments Restrictions to provide information on progress therewith by mid-1994 (BOP/R/211 par.17), I have pleasure in attaching a copy of Government notice No. R. 1130 of 23 June 1994, listing further removals from import surcharge since South Africa's last notification as contained in L/5898/Add.2.
