# ARRANGEMENT REGARDING INTERNATIONAL TRADE IN TEXTILES

Notification under Article 4:4

Amendment of the Bilateral Agreement between the United States and Guatemala

The Textiles Surveillance Body received a notification from the United States of an amendment of its agreement with Guatemala for the period 28 May 1993 to 31 December 1994.<sup>1</sup>

The Embassy of the United States of America presents its compliments to the Ministry of Foreign Relations of the Republic of Guatemala and has the honour to refer to the Bilateral Textile Agreement between the United States of America and the Republic of Guatemala signed 20 July 1993 in Guatemala City ("the Agreement"), to the Memorandum of Understanding, signed 22 July 1993 in Guatemala City, and to our Diplomatic Note Number 25 of 22 February 1994. This Note supersedes our Diplomatic Note No. 25 which contained two errors. Pursuant to the Memorandum of Understanding, the Embassy has the pleasure of proposing the following amendment to the Agreement:

1. Amend Annex A of the Agreement to include:
