ARTICLE XXVIII NEGOTIATIONS - 1960

Notification of Results of Negotiations

1. The following rules are based on those contained in document L/635 issued for the 1957 Negotiations under Article XXVIII.
2. Upon completion of each bilateral negotiation, the "applicant contracting party" should:
  - (i) prepare a report on the lines of the model in Annex A attached hereto. One hundred copies should be sent to the Executive Secretary for distribution to contracting parties as addenda to the secret document containing the original notification.
  - (ii) send to the secretariat a joint letter (as per model in Annex B attached hereto) signed by both parties to which shall be attached one copy of the report mentioned under (i). (This copy of the report should be initialled by both parties.)
3. Upon the completion of all its negotiations, the "applicant contracting party" should send to the Executive Secretary, for distribution in a secret document, a report (in triplicate) on the lines of the model in Annex C attached hereto.
4. Contracting parties will be free to give effect to the changes agreed upon in the negotiations as from 1 January 1961.
5. Contracting parties should notify the Executive Secretary of the date on which they give effect to the agreed schedules, and compensatory concessions should be made effective not later than that date.
