## THE SUBMISSION OF REQUESTS LISTS

## Note by the Secretariat

- 1. At the last meeting of the Trade Negotiations Committee of Developing Countries, on 13 December 1968, it was agreed that the process of bilateral consultations and the exchange of information should be completed in March 1969 and that specific lists of requests, addressed to individual participating countries, should be filed in April.
- 2. Following the practice of past tariff and trade negotiations in GATT, delegations will no doubt wish to make out their request lists in similar form so as to facilitate handling and processing. Attached is a suggested form which delegations are urged, in so far as possible, to adopt for this purpose. (Delegations which have already prepared copies of their requests lists should, however, feel free to submit them in whatever form may have been adopted, especially if recasting and retyping would entail any delay in the transmission of their lists.)
- 3. Such requests lists should be transmitted directly by each participating country to the delegations of the respective countries from which a concession or concessions are requested. Fifty copies of each requests list should be sent, simultaneously, to the GATT secretariat for distribution to the other participating countries.
- 4. In accordance with the decision of the Committee and taking account of practical circumstances, it is suggested that such lists should be submitted wherever practicable by 10 April 1969, or as soon as possible thereafter.
