SUBMISSION OF REQUEST LISTS .

Note by the Secretariat

At the last meeting of the Committee held on 16 February 1970 certain working rules for the trade negotiations among developing countries were generally agreed upon. In order to enable participating countries to move as rapidly as possible into the substantive phase of the negotiations, the Chairman suggested certain target dates for the presentation of request lists and offers (cf. TN(LDC)27). Request lists so far received are detailed in the annex to this note. In order to facilitate bilateral consultations between delegations, countries having exchanged request lists reciprocally are shown separately.
