SUBMISSION OF SPECIFIC REQUEST LISTS

Note by the Secretariat

In order to facilitate bilateral consultations among governments participating in the trade negotiations among developing countries, the secretariat has updated the information contained in TN(LDC)23, 25 and 28 regarding request lists addressed to one another by participating countries. Annex A to this note lists the request lists presented by sixteen participating governments; Annex B shows, in a tabular form, the situation for all the participating countries; Annex C shows pairs of countries which have exchanged requests reciprocally; and Annex D lists the membership of the Trade Negotiations Committee.
